THE HEALTH CENTER STRIVES TO PROVIDE THE UNDER-SERVED HEALTH CARE POPULATION IN THE CORPUS CHRISTI COMMUNITY WITH THE HIGHEST MEDICAL CARE AVAILABLE. IN 2012, AMISTAD SERVED 4,430 PATIENTS WITH 14,375 VISITS. APPROXIMATELY 50% OF THE SERVICES PROVIDED HAVE BEEN TO UNINSURED AND UNDERINSURED INDIVIDUALS.
